Any individual or agency requesting services of KPETS shall likewise take necessary steps to insure that those individuals coming in contact with KPETS volunteers or pets likewise adhere to applicable governmental regulations and advisories in place at the time of the contact. Any violation of this paragraph may result in the immediate cessation of KPETS Service.
